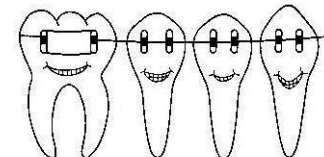

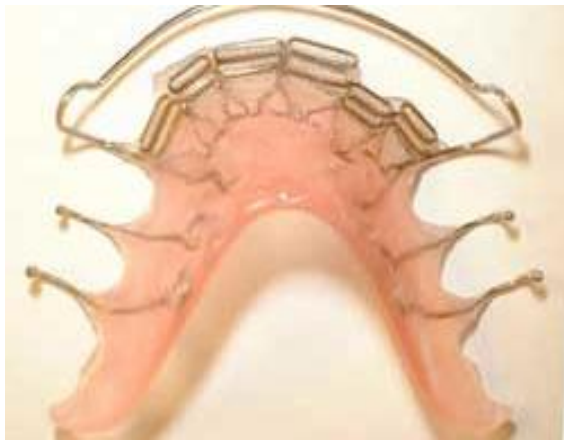

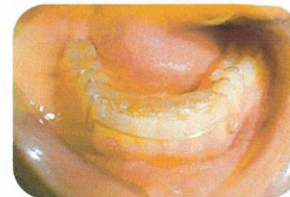

Retainer cost for the doctor \$160

Retainer cost for the patient

\$1750 (2 X \$875)
